3. Any storage and reefer charges at the port or the inland facility are not included in the tariff, all these charges should be paid by the customer directly.
4. COSCO SHIPPING Lines admits 4 extra calendar days free for Door shipments in France.
5. Reefer NOR is charged by the reefer tariff.
6. Hanger container is charged by the dry container tariff.
